## BANCO DESIO: THE SUBSIDIARY FIDES S.P.A. HAS COMPLETED THE FIRST SECURITISATION OF RECEIVABLES DERIVING FROM PERSONAL LOANS, WITH THE ISSUE OF NOTES FOR AROUND € 255 MILLION

Desio, 12 December 2024 - Fides S.p.A., a financial intermediary 100% controlled by the parent company Banco Desio, has completed the first transaction securitising receivables deriving from personal loans. BNP Paribas acted as the arranger.

The transaction was structured pursuant to Law 130/1999 through the issue of asset backed securities for an aggregate principal amount of € 254.7 million.

The transaction is consistent with the Banco Desio Group's strategy of growth in the area of personal finance and is functional to the pursuit of Fides' objectives in the horizon of its business plan, in continuity with the excellent results achieved in 2024.

"We are satisfied to have completed the 2024 funding plan with this new securitisation, the first with underlying personal loans, the conditions of which represent a confirmation of the credit quality and the careful disbursement policies adopted by the Banco Desio Group", commented Chief Executive Officer Alessandro Decio.

The senior notes issued as part of the transaction, equal to € 215 million, were subscribed by BNP Paribas, while the junior notes were undersigned by the Originator also for regulatory purposes of maintaining the net economic interest.

The transaction meets the requirements of "simplicity, transparency and standardisation" (STS) set forth in Regulation (EU) 2017/2402.

Legance assisted BNP Paribas as attorney for the arranger, while A&O Shearman acted as attorney for the originator.
